In consideration of the risk of personal injury while participating in dance, dance-instruction, and any other dance-related activity (individually and collectively referred to as the "Activity"), and as consideration for the right to participate in the Activity, I hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Activity, and I do hereby release and forever discharge DANCE TO INSPIRE, LLC, its affiliates, managers, members, agents, independent contractors, attorneys, staff, volunteers, customers, on-site vendors, subtenants, heirs, representatives, predecessors, successors and assigns (collectively, "the Released Parties"), for any physical or psychological injury, including but not limited to illness, paralysis, death, damages, economical or emotional loss, and for any property damage that I may suffer as a direct result of my participation in the aforementioned Activity, including traveling to and from an event related to this Activity.
